## Exhibitor Liability Insurance Program

As a standard requirement for all our show exhibitors, it is necessary for you to carry general liability coverage from an insurance company in good standing with minimum policy limits of \$1,000,000 per occurrence and \$2,000,000 aggregate. Insurance Coverage is not optional.

This insurance must be in force during the lease dates of the event, naming School Nutrition Association (2900 S. Quincy Street Suite 700 Arlington, VA 22206) as the certificate holder. The following must be named as additional insured: School Nutrition Association, Boston Convention Center, City of Boston, and it's officers, agents, and employees and Global Experience Specialists (GES), MCCA, and Levy Premium Foodservice.

SNA has requested that Rainprotection serve as their insurance management company. In addition to being able to provide exhibitors with insurance, we are also collecting and verifying that all insurance certificates, regardless of the insurer, are verified for compliance.

## Rainprotection Insurance Program
